

**WARREN COUNTY RURAL ELECTRIC
MEMBERSHIP CORPORATION**

RIDER GSOP-0011
GENERAL SERVICE OFF-PEAK ENERGY RIDER

The Warren County Rural Electric Membership Corporation (REMC) shall charge and collect for general service off-peak service on the following bases of availability, application, character of service, monthly rate, minimum charge, rate adjustment clauses, and tax adjustment.

AVAILABILITY:

This schedule is available to any member of Warren County Rural Electric Membership Corporation who was taking service under Rider GSOP-0011 as of October 31, 2020 and meets the eligibility criteria set forth herein and is located in the territory served by the REMC. This Rider is closed to new load as of November 1, 2020.

APPLICATION:

Applicable to any member of the REMC taking delivery under general service single-phase or three-phase as an optional rider for separately metered energy used by appliances and apparatus suitable to off-peak energy usage. Energy provided under this schedule may be metered to ensure that usage does not occur during system peak periods. Appliances and apparatus served under this schedule shall be mutually agreed upon by the consumer and the REMC. All other energy shall be rendered under the general service schedules.

CHARACTER OF SERVICE:

The type of service rendered under this schedule shall be single or three phase, 60 Hertz, alternating current at the REMC's available standard voltage. Service shall be for the sole use of member and shall not be resold by member to any other person or entity.

MONTHLY RATE:

WHOLESALE POWER AND OTHER COST ADJUSTMENT CLAUSE:

This Rate Schedule is subject to the Wholesale Power Cost Adjustment Clause set forth in Appendix A, all other applicable Riders, and all non-recurring charges which may be amended from time to time in the sole discretion of the Board of Directors.

MINIMUM CHARGE:

The monthly minimum charge under this rate schedule shall be the Customer Charge, \$85.00

TAX ADJUSTMENT:

The amount computed at the above monthly rate as adjusted by the application of the rate adjustment clauses shall be subject to taxes, assessments, and surcharges imposed by any governmental authority.

TERMS AND CONDITIONS OF SERVICE:

1. a) Electric Service provided hereunder is subject to the provisions set forth in the Warren County Rural Electric Membership Corporation's Bylaws, Service Rules & Regulations, and Policies, as may be amended from time to time in the sole discretion of the Board of Directors.

b) Billing and Payment for electric Service provided under this Rate Schedule is subject to the provisions set forth in the Warren County Rural Electric Membership Corporation Bylaws, Service Rules & regulations, and Policies, as may be amended from time to time in the sole discretion of the Board of Directors.
2. The rates and charges set forth in this Rate Schedule are subject to change at any time in the sole discretion of the Board of Directors.
